
**Subject: Construction of Building for Training Institute of CBCRD Trust –Honnenahalli**

We refer to tender document dated 29.12.2011 and the pre-bid meeting held on 09.01.2012 in connection with the subject works. Based on the clarification sought during the pre-bid meeting, the following clarifications and amendments are made; this shall form part of the tender document

Sl No.	Clarification Sought	Clarification and Amendments
1	Bills of quantities in Price Bid	It is clarified that the quantities mentioned in the BOQs are the sum of the total quantities of various buildings within the same premises.
2	Item no. 2 page 2/26 of Price Bid-Earth work excavation	Item no. 2 is for earth work excavation for all types of soils upto 1.5 m depth. The item 2 ii is deleted from the scope of work.
3	Item no. 3 page 2/26 of Price Bid-Earth work excavation	Item no. 3 should be read as excavation for all types of soils for depth of more than 1.5m and upto 2.5m. Item no. 3 ii is deleted from the scope of work.
4	Item no. 15 page 5/26 of Price Bid-Compressive strength of brick	Compressive strength of the bricks should be 3.5N/sq mm
5	Item no. 31 page 9/26 of Price Bid-MS tube railings	MS hollow pipes to be of 18 gauge
6	Item no. 1/i page 13/26 of Price Bid-Earth work excavation	It is clarified that the earthwork excavation is for all types of soils upto 1m depth and item no.1/ii with a quantity of 5.78 cum stands deleted.
7	Page no. 10 of Technical Bid, Sl no. F 1 & 2	The same should be read as F: EXPERIENCE RECORD. 1. DETAILS OF "BUILDING WORKS" COMPLETED DURING LAST SEVEN YEARS, COSTING MORE THAN RS. 36 LAKHS EACH 2. DETAILS OF WORKS IN HAND COSTING MORE THAN RS. 36 LAKHS EACH
