## GENERAL RULES & INSTRUCTIONS TO AGENCIES

**SUBJECT: Tender Document for Special Courier agencies for Circle Office, Jaipur**

1. The tender documents consisting can be collected between the dates mentioned in the Notice Inviting Tender (NIT) during the working hours (between 10.00 a.m. to 05.00 p.m.) everyday except on Sundays and Public Holidays, as specified in NI Act, at the office of the Manager, Premises and Estate Section, Circle Office, Jaipur. OR the document may be downloaded from website of the Bank [www.canarabank.com](http://www.canarabank.com).
2. The Application fee of Rs. 500/- (incl GST) may be paid in cash while collecting the documents from the P&E Section, Canara Bank, CO, Jaipur or submitted by the way of Demand Draft favouring **Canara Bank** payable at Jaipur along with tender document.
3. **Earnest Money Deposit (EMD):** The EMD should be submitted by way of Demand Draft on Jaipur favoring "Canara Bank, Circle office, Jaipur" from any Nationalized / Scheduled Bank. Tender without EMD shall be summarily be rejected. The EMD shall not carry any interest.
4. The sealed offers should be deposited in the **Tender Box kept at Premises & Estate Section, Canara Bank Circle office, Orbit Mall, Ajmer Road, Jaipur-302006 on or before 05/04/2019, 3:00 PM.** If last day of submission of bids is declared a holiday under NI Act by the Government subsequent to issuance of NIT the next working day will be deemed to be the last day for submission of the offer. No offer will be accepted by post or courier or email or FAX.
5. The sealed tenders will be opened on the date stipulated in the NIT at Premises & Estate Section, Canara Bank Circle office, Orbit Mall, Ajmer Road, Jaipur-302006 If date of opening of tender is declared a holiday under NI Act by the Government subsequent to issuance of NIT the next working day will be deemed to be the date of opening of the Tender.
6. Both the envelope super-scribed as " Technical & Commercial Bid" and "Price Bid " will be simultaneously accepted, but the envelope super-scribed as "Technical & Commercial Bid " alone will be opened and details of EMD etc., shall be recorded, while the Price Bid shall be maintained in the safe custody of the Employer if it is not opened on scheduled date & time.
7. **In the first stage, offers will be evaluated against the stipulated parameters and conditions of the Bank. Offers not complying with these will be rejected summarily.** In the second stage, after the technical and commercial evaluation, if necessary after discussions with the tenderer, such of those tenderer found technically & commercially acceptable will be short listed and their envelope containing " Price Bid " shall be opened on a given date and time in presence of the short listed tenderers with prior notice to them. The tenderers are

expected to attend the tender opening and their inability in participating will not in any way prevent the employer undertaking the opening of the bids.

7. Tender shall be submitted on prescribed Form only (i.e. as per documents issued) have to be duly filled and submitted and no other format shall be used, except for Proformas which shall be submitted in the letter head. Wherever required, particulars can be submitted in annexure but such details shall be clearly mentioned in respective columns in the original document. All the documents, enclosures, and correspondence will form the part of contract. Offer in any other format other than the prescribed in this document shall be liable for rejection. The applicant shall submit an undertaking in **Proforma E** stating that no changes, alterations are made in the offer documents issued by the Bank. **The rate quoted** shall be inclusive of all / charges payable to the associate consultants, Income tax (TDS) but exclusive of GST, which shall be paid on production of proof of payment.
8. Offers which are incomplete in any respect are liable to be rejected.
9. Canvassing in connection with tenders is strictly prohibited and the offers submitted by the courier agencies who resort to canvassing will be liable for rejection.
10. Conditional offers shall be summarily be rejected.
11. The applicant shall furnish the list of his relatives working in the Canara Bank with their present place of posting in the **Proforma A**
12. The applicant shall furnish the list of retired Government /PSU / Banks employees, employed by him with full details of their previous employment in **Proforma A**.
13. The tender shall remain open for acceptance for a **period of 90 days from the date of opening**. No tender can be modified or withdrawn by the courier agencies after submission of the Bid. If any courier agencies withdraws his offer before the said validity period or makes any modifications in the terms and conditions of the offer which are not acceptable to the Bank, then the Bank shall, without prejudice to any other right or remedy, be at liberty to **forfeit full value of the Earnest Money Deposit** as aforesaid.
14. The courier agencies or their authorized representatives with an authorization letter as per **Proforma B**, are requested to be present during the opening of the bids. Bank will proceed with opening of the commercial bids / financial bids on the stipulated date & time unless other wise modified with prior intimation to the Applicants.
15. It will be obligatory on the part of the courier agencies to tender and sign the offer documents for all the component parts.

16. The Bank's decision in the selection process is final and Bank will neither entertain any correspondence in this regard nor will be bound to furnish any explanation. The acceptance of a offer will rest with the Bank which does not bind itself to accept the lowest offer and reserves to itself the authority to reject any or all of the offers received without assigning any reason.
17. The successful agencies will be based on the region wise lowest offer. The service will be awarded on region wise basis.
18. The successful courier agencies shall execute the agreement on a stamp paper of appropriate value within 14 days from the date of receipt of the acceptance letter issued by the bank , and until a formal agreement on stamp paper is prepared and signed, this offer document along with the correspondence shall constitute a binding contract between the courier agencies and the Bank/ Employer.
19. On acceptance of the offer , the name of the accredited representative(s) of the courier agencies who would be responsible for taking instructions from the Bank / Employer shall be communicated to the Employer.
20. In case of unsuccessful tenderer the EMD shall be returned without any interest within 15 days of award of the contract to the successful courier agency.
21. **SECURITY DEPOSIT:** An amount of Rs. 10000/- shall be deposited with the bank for due performance of the contract within 14 days from the date of receipt of the acceptance letter issued by the bank. The security deposit shall be remitted by way of DD in favoring "Canara Bank, Circle office, Jaipur" payable at Jaipur. The security deposit shall be held by the bank for the contract period and shall not earn any interest. The EMD submitted shall be adjusted towards the security
22. The EMD of the successful agency shall be forfeited in case the successful agency fails to enter into an agreement and fails to remit the security deposit within the stipulated time fixed for them.

## GENERAL CONDITIONS OF CONTRACT

**SUBJECT: Tender Document for Special Courier agencies for Circle Office, Jaipur**

### 1. DEFINITIONS:

FOR the purpose of the agreement, the following words and expression shall have the meaning hereby assigned to them except where the context otherwise requires:-

- (i) 'Approved' means approved by Bank's representative in writing including subsequent confirmation of previous approval and 'Approval' means approval by Bank's representative in writing as above said.
- (ii) 'Bank' means the CANARA BANK which expression shall unless excluded by or repugnant to the context include its representative.
- (iii) 'Bank's representative' means the Assistant General Manager, Canara Bank, Premises & Estate Section, Circle Office Jaipur or any person authorized by him as in charge of the service and would sign the agreement on behalf of the CANARA BANK.
- (iv) "Courier Agency" means M/s. \_\_\_\_\_ or their assigns or successors in office and authorised representative.

2. The successful COURIER AGENCIES shall undertake the services by themselves but shall not sublet or assign or transfer or sub contract any part of the services.

3. No personnel employed by the COURIER AGENCIES for the service will be liable for any sort of compensation or employment from the Bank.

### 4. SCOPE OF SERVICES

The scope of the services shall be to collect the sealed covers from Canara Bank, Circle Office, Jaipur premises situated at Orbit Mall, Civil Lines, Ajmer Road, Jaipur any time between 08 AM to 06 PM and delivering the same to any cities in the region outside Jaipur within the time period specified for the each centre.

### 5. RATES

The tenderers should quote their rates regionwise on rate per unit basis as prescribed in the price bid. Quoting of rates any other form will render the tender as invalid and same shall be rejected.

The quoted rate shall be inclusive of all charges for the labour, freight, tamper proof packing, profits, and statutory taxes except GST. Income tax as per statutory orders / laws shall be deducted at source. TDS certificate shall be issued for such deductions.

## 6. PAYMENTS:

The payments shall be based on the rates quoted in price bid and subsequent modifications if any. The payments shall be made by the Bank once in month based on the total number of covers / packets collected & delivered satisfactorily. The total numbers of covers / packets shall be counted based on the proof of delivery (POD) submitted by the agency.

The payment will be paid for as “measured work” on the basis of actual work done on item rate basis and not as “lump sum” contract as per the rate quoted in the price bid.

The rate quoted shall be firm through the contract period and no escalations shall be permissible.

The rate shall be quoted on weight basis i.e. per gram per cover/ packet/ consignment. The minimum chargeable weight shall be 50 gms.

**7. SECURITY DEPOSIT:** An amount of Rs 10000/- shall be deposited with the bank for due performance of the contract. The EMD submitted shall be adjusted towards the security. The security deposit shall be refunded after successful completion of the contract without any interest after recovering the entire amount due from the agency.

**8. TIME SCHEDULE :** The delivery of the consignments shall be made within the time stipulated as below from the time of pick up at Jaipur Circle Office:

In case the next day ( within 24 hours) is holiday/ weekly holiday the delivery shall be made on the next working day

**9. PERIOD OF CONTRACT:** The duration of the contract shall be for period of two year from the date of signing the agreement.

**10. PACKING:** Necessary tamper proof packing shall be provided by the Courier agency within the quoted rates.

**11. LIQUADATED DAMAGES:** The time allowed for carrying out the service shall be as specified in clause 8 above shall be deemed to be the essence of the contract on the



part of the courier agencies. The service shall be provided throughout the stipulated period of the contract with all diligence and in the event of failure of the courier agencies to provide the service within time schedule as specified above or subsequently notified to him, the courier agencies shall pay as compensation amount equal to Rs 100/- per day per consignment/ cover/ packet or such smaller amount as the Bank may decide subject to a maximum of Rs 10,000/-. Further the delayed consignments/ covers/ packets shall not be eligible for any payments.

**12. COMPENSATION FOR LOSS/ DAMAMGE OF COVER / PACKETS / CONSIGNMENTS:**

The courier agency shall be responsible for loss/ damage of Cover/ packets / consignments during the transit and shall compensate the Bank for the expenses incurred for retrieval of the documents / correspondence lost in the transit. The amount of compensation shall be paid by the Courier agency failing which it shall be recovered from the Security deposit or from any amount due to the Courier agency or by a way of suit.

**13. FORCE MAJEURE**

The courier agency shall not be liable for default or non-performance of the obligations under the contract, if such default or non-performance of the obligations under this contract is caused by any reason or circumstances or occurrences beyond the control of the bidder, i.e. Force Majeure.

For the purpose of this clause, “Force Majeure” shall mean an event beyond the control of the bidder, due to or as a result of or caused by acts of God, wars, insurrections, riots, earth quake and fire, events not foreseeable but does not include any fault or negligence or carelessness on the part of the bidder, resulting in such a situation.

In the event of any such intervening Force Majeure, the courier agency shall notify the Bank in writing of such circumstances and the cause thereof immediately within five calendar days. Unless otherwise directed by the Bank, the Bidder shall continue to perform / render / discharge other obligations as far as they can reasonably be attended / fulfilled and shall seek all reasonable alternative means for performance affected by the Event of Force Majeure.

In such a case, the time for performance shall be extended by a period (s) not less than the duration of such delay. If the duration of delay continues beyond a period of three months, the Bank and the courier agency shall hold consultations with each other in an endeavor to find a solution to the problem.

Under no circumstances the courier agency will be entitled to any compensation, damages or extra cost. Notwithstanding above, the decision of the Bank shall be final and binding on the courier agency.

**14. RESTRICTION / SUSPENSION:** The Bank reserves the right of restricting the courier agencies services at any stage and makes other arrangements for continuing the services after withdrawing such services from them or suspends the service.

The Bank shall have the liberty to omit, postpone or not to execute any service and / or any item of service and the courier agencies shall not be entitled to any compensation or damages for such omission, postponement, or non- execution except the charges which have become payable to them for the services actually rendered by them.

#### 15. TERMINATION OR RECESSION OF AGREEMENT:

The Bank without any prejudices to its right against the courier agencies in respect of any delay or deficient service by notice in writing absolutely determine / suspend the contract in any of the following cases;

1. If the courier agencies being a company shall pass a resolution or the court shall make an order that the company shall be wound up or if a receiver or a (Manager on behalf of the creditor shall be appointed or if circumstances shall arise which entitle the court or the creditor to appoint a receiver or Manager or which entitles the court to make up a winding order.
2. If the courier agencies is not pursuing the service with due diligence within the time lines committed or abandons the services or commits breach of any of the terms of the agreement and when the courier agencies has made himself liable for action under any of the cases aforesaid the Bank shall have powers:
  - a. To determine or rescind or suspend or terminate the agreement
  - b. To engage another courier agencies to carryout the balance service debiting the courier agencies the excess amount if any so spent.

In the event of the termination of the agreement by the Bank the courier agencies shall not be entitled to any compensation or damages by reason of such termination, but only to the charges for the service actually rendered, which have been duly approved by the Bank. The decision of the Bank as regards the actual service done and the amount of the charges due to the courier agencies on the basis of actual service / service done shall be final and binding on the courier agencies.

The courier agencies shall promptly notify the Bank of any change in the constitution of its/ his firm. It shall be open to the Bank to terminate the Agreement on the death, retirement, insanity or insolvency of any person being Director in the said firm, or on the addition or introduction of a new Director. But until its termination by the Bank as foresaid, this contract agreement shall continue to be in full force and effect, notwithstanding any changes in the constitution of the firm by death, retirement, insanity or insolvency of any of its Director or addition or introduction of any new Director. In case of death or retirement, the surviving or remaining Directors of the firm shall be jointly and severally liable for the due and satisfactory performance and for compliance of all the terms and condition of this contract agreement.

## 16. ABANDONMENT OF WORK :

If the courier agencies closes their business or abandons the service or if this agreement is terminated as provided for in clause 11 hereinbefore, the Bank shall be entitled to forfeit the Security deposit.

As a special case in case of proprietary firms and in case of death of the proprietor the forfeiture of Security deposit is waived.

## 17. ARBITRATION

That if any dispute, difference or question shall at any time arise between the parties in respect of the meaning or construction of this agreement, or covering anything therein contained or arising out of this agreement, or the validity of the enforcement thereof which cannot be settled mutually, shall within 30 days ( or such longer period as may be mutually, agreed upon) from the date one party informs the other in writing that such dispute or disputes or disagreement exists, be referred to sole arbitration by a person selected by the courier agencies out of the panel of three names supplied by the Bank and appointed by THE ASSISTANT GENERAL MANAGER, PREMISES & ESTATE SECTION within 30 days from such selection by the AGENCIES.

The arbitration proceedings will be conducted in accordance with and be subject to the Indian Arbitration Act 1996 as amended from time to time and the decision of the arbitrator shall be final and binding on the parties.

The Arbitrator will have his seat at JAIPUR or at such places in India as decided by the appointing authority. The Arbitrator may, with the written consent of the parties, extend time for making and publishing the award.

The courier agencies shall continue to perform his duties with diligence notwithstanding the fact that the dispute has been referred to Arbitration or any dispute or difference has arisen.

It is also the term of the agreement that if the courier agencies does not make any demand for arbitration in respect of any item in writing within 90 days of receiving intimation from the Bank that the final bill is ready for payment, the claim of the courier agencies will be deemed to have been waived and absolutely barred and the Bank shall be discharged and released of all liabilities under the agreement in respect of these claims.

The court of jurisdiction shall be in Jaipur only.

## 18. PENAL CONDITION:

If service carried out by the courier agencies is found to be sub-standard or unsatisfactory , un-duly delayed on his account, Bank suffers loss, does not maintain the confidentiality of the contents of the courier then the Bank shall report to IBA, the misbehavior of the courier agencies and IBA in turn may inform all the

member Banks, other financial institutions , government departments after examining veracity of the Bank's version, not to deal with such courier agencies by way of punishment to him.
