TERMS & CONDITIONS OF OFFER

- 1. The offered vehicle should be a Bolero Plus 9-seater vehicle with AC and power steering and BS-4 emission norms compliant.
- 2. Offerers are to have a minimum 03 years experience in providing cash van services to banks / cash replenishment agencies.
- 3. The hire charges is on **consolidated monthly** basis including cost of fuel, replacement of tyres, toll taxes / charges, breakdown maintenance, periodical maintenance/ services, driver's salary, their Bata, insurance etc and all inclusive and **nothing extra will be payable**.
- 4. The vehicle to be modified as per the Bank's requirement at owner's cost movement of cash / treasure.
