NOTICE FOR EMPANELMENT OF CONTRACTORS / SUPPLIERS / VENDORS

The Premises & Estate Section of Canara Bank Lucknow Circle Office is managing Bank's branches/offices/other business and non business units spanning across various locations in 66 districts in the state of Uttar Pradesh. The branches/offices are further controlled down the line by 8 Regional Offices located in Agra, Aligarh, Bareilly, Etah, Gorakhpur, Kanpur, Lucknow & Varanasi.

The intention of this notice of empanelment is to maintain a unanimous panel of contractors for the following trait:

- a) Fire Extinguishers & Fire Fighting Equipments.

All contractors / suppliers / vendors in the existing panel should also apply afresh for empanelment.

The eligible and interested architects & contractors and suppliers may download "Document for empanelment" from the Bank's website www.canarabank.com.

Alternatively, the document can also be collected from the above office on payment of non-refundable fee of Rs.500/- in the form of cash.

The duly filled in application addressed to the Assistant General Manager, along with all the necessary supporting documents & a non-refundable application fee of Rs.500/- in the form of DD favouring "Canara Bank, Circle Office" payable at Lucknow shall be submitted to the mentioned correspondence address before the stipulated date & time. The applications without the application fee would be rejected.

The application fee is waived for those applicants who opt to collect "Document for empanelment" from the address mentioned above instead of downloading it from the website.

The duly completed document in the prescribed format with all supporting documents shall be sealed in a cover and super scribed as 'APPLICATION FOR EMPANELMENT OF CONTRACTORS / SUPPLIERS OF FIRE EXTINGUISHERS & FIRE FIGHTING EQUIPMENT - 2018' and shall be submitted to the above mentioned office of CANARA BANK on or before 15/10/2018 up to 05.00 pm.

The Bank reserves the right to accept or reject any or all the applications without assigning any reasons thereof and their decision of selection will be final.

GENERAL RULES AND INSTRUCTIONS

1. Generally, the routine works of the Bank are awarded/ procurements are made on calling competitive tenders/quotations from the empanelled contractors. In case of emergency works or works of small magnitude, the Bank may opt to award the work/ procure supply on nomination basis from any of the empanelled contractors, depending on the geographical suitability, exigencies of the work. Bank also has the right to adopt open tendering process for any particular work, depending on the nature & magnitude of the work.
2. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexure but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
3. All contractors in the existing panel should also apply afresh for empanelment.
4. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
5. **Documentary proof with respect to the prequalification criteria shall be furnished along with the application form. In this regard, copies of the work orders and completion certificates and or such other documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.**
6. The authorised person of the firm/ company shall sign in all the pages of the application with seal of the company/ firm.
7. The evaluation will be based on the experience, reputation, empanelment with other Banks, PSUs, Govt. institutions, manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc and if found necessary may also include inspecting the works undertaken by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection/ rejection for empanelment will be final and binding and no further correspondence will be entertained. Only the empanelled contractors will be informed by post.
8. If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
9. Applications received after the due date and time is liable for rejections.
10. The present empanelment is mainly for works for value up to the limits mentioned in respective categories. In case of any high value works, Bank may undertake the works by project specific pre-qualification exercise.

11. The applicants having their registered offices within the specified limits of Canara Bank's Circle Office and Regional Offices will be preferred.
12. The applicant must ensure compliance with the labour laws and guidelines.
13. Canara Bank reserves its right to reject any/ or all the applications without assigning any reasons whatsoever.
14. Empanelment with the Bank is in no way whatsoever a guarantee that the empanelled consultant/ contractor would be awarded all or any works desired to be executed by the Bank after their empanelment. Nor does the empanelment with the Bank entail that the Bank, in any way whatsoever, is bound to involve the panel consultant / contractor in the process of tendering, calling for quotations or any other similar exercise undertaken before award of work.
15. The applicant must have a valid ESIC & RPFO registration number. The copy of the ESIC & RPFO registration certificate should be enclosed. In case an applicant is finalised by the Bank for empanelment but the applicant does not possess a valid ESIC & RPFO registration number, the applicant must immediately apply for obtaining the ESIC & RPFO registration number and furnish the same within 3 weeks from the date of receipt of conditional confirmation of empanelment from the Bank. Failure to do so will lead to cancellation of empanelment.

Note:

1. If other things are found equal, the professionally qualified applicants and the applicants who have undertaken the works for Government organizations will be preferred.
2. All class & types of applicants must be Income Tax Assessee. The applicants, otherwise eligible but not Income tax assesses, will not be considered for empanelment.
3. All applicants should be registered with tax authorities. If they are otherwise eligible but not registered for GST, they will not be considered for empanelment.
4. Based on the assessment of details furnished like works undertaken, technical & financial capabilities, selection will be made. From such panel, competitive offers/tenders will be called for specific works.

SCOPE, ELIGIBILITY CRITERIA AND RELATED DETAILS

CONTRACTORS / SUPPLIERS / VENDORS FOR FIRE EXTINGUISHERS & FIRE FIGHTING EQUIPMENTS

Eligibility:

The applicant should have the following minimum eligibility criteria:

1. The applicant should be a firm / registered company which must either be the original equipment manufacturer or a subsidiary company of a manufacturer company or an authorized supplier/channel partner of a manufacturer thereof of fire extinguishers like Ceasefire, Safex, Minimax, Canex or any other equivalent brand.
2. The Applicant or its OEM should must have a valid BIS certificate / license (as on the date of application) for manufacturing Fire Extinguishers. Copy of the certificate / license to be annexed with the application.
3. The applicant should have an annual turnover of Rs. 50.00 Lacs for the past 3 Financial Years with an undertaking from a qualified Chartered Accountant dignifying that the turnover is from works specific to the category applying in.
4. The applicant should furnish a solvency certificate from its Banker authenticating credit worthiness of Rs. 20.00 Lacs issued after 31.03.2018. The applicant can also furnish an equivalent certificate confirming the financial health of the applicant in lieu of the aforementioned solvency certificate. The right to accept such “equivalent certificate” rests solely with the Bank.
5. The applicant should have undertaken works in Public Sector Banks (PSB)/ Government Departments/ Public Sector Undertaking (PSU)/ Central Autonomous Bodies/ State Autonomous Bodies/ Financial Institutions and other reputed private firms during last 5 Financial Years up till 31.03.2018. It is mandatory for the applicant to have rendered sales and services in 3 different Public Sector Banks during this period.
6. In respect of Public Sector Banks (PSBs), the applicant must have executed supply and installation of equipment in at least 500 branches / Administrative Units during the past 5 Financial Years up till 31.03.2018 and must have undertaken the annual maintenance of equipment installed in at least 1000 branches / Administrative Units during the same time frame.
7. The applicant must have executed similar works, albeit for different customers, all aggregating to a cumulative amount of Rs. 50.00 Lacs in at least one of the preceding 5 Financial Year up till 31.03.2018. Copies of work orders / completion certificates authenticating qualification of this criterion should be separately and properly annexed.
8. The applicant should furnish an authorisation certificate from its OEM in original along with a confirmation letter from the OEM stating that the

applicant would supply spare parts for the models manufactured by the OEM for a minimum of 3 successive years from the date of installation. This confirmation letter must be in Original and no photocopy or coloured Xerox will be acceptable. The authorisation certificate and the confirmation letter should be issued within a month prior to the date of application.

9. The applicant should submit a "Satisfactory Performance Certificate" from at least 2 prior / present customers out of which 2 must be PSBs/ RRBs on whose panel it is conducting business related to sale and service of Fire Extinguishers. The certificate should be issued within a month prior to the date of application.
10. The applicant should not have been blacklisted by any PSU/PSB/Govt Organization in past 5 years or services terminated due to poor performance. A certificate be submitted stating that the company/firm or its owner or any sister concern have not been blacklisted. If the information provided by the applicant in this regard is found incorrect at a later date, then the candidature of the applicant shall be cancelled with immediate effect, notwithstanding successful empanelment of the applicant with the Bank.
11. The applicant should be an assessee of Income Tax and must possess a valid GST Registration. Applicant should submit copies of the income tax returns, PAN & other pertaining documents.
12. The applicant should have a wide dealership / service network in the geographical Jurisdiction of Uttar Pradesh. The Regional Office wise distribution of the districts under the aegis of Canara Bank's Lucknow Circle Office is mentioned earlier for the perusal of the applicant. The applicant, if added to the panel, shall have to undertake to supply equipment and provide post sale services to those equipment in branches / offices in these areas.
13. The applicant shall provide details of the key personnel, branches / offices, equipment and manufacturing facilities.
14. Bank reserves the right to visit/inspect Applicant / Manufacturer facilities to ascertain the above facts. The Bank's representatives may visit the applicant's factory site/offices and contact his past clients for verification of information given by the applicant. The applicant will be required to give them the necessary facilities for verification.
15. The applicants who are shortlisted after the preliminary screening will be invited by the Bank to demonstrate the range and functional efficacy of the equipment offered by them at a venue in Lucknow on the date & time notified by the Bank. If any applicant refuses to put forward such a demonstration, its application would be rejected.
16. The applicant shall submit a catalogue on the product offered along with the application.
