## Canara Bank raises Rs.2,000 crore in Basel III-compliant Additional Tier I (AT1) Bonds 2023-24 Series II

However, it may be called back by the issuer after five years or any anniversary date thereafter subject to prior approval of the RBI. The Bank's AT1 bonds are rated AA+/Stable by CRISIL Rating and ICRA Ltd.
