GENERAL TERMS AND CONDITIONS

1. The successful bidder will be given Work Order on periodical basis in respect of publication of the notices under SARFAESI Act, 2002 in the leading newspapers as and when required. The matter to be advertised along with the names of the newspapers would be intimated along with the requisition.
2. The rates offered by the successful bidder will remain unchanged during the period of the Work Order. However, the benefit of downward rates, if any, is to be given to the Bank.
3. The rate to be offered should be all inclusive. However, GST as applicable will be extra. No other charges / taxes would be considered.
4. The Bank reserves the right to give a special work order to any other agency for any particular public notice during the period of the Work Order.
5. The Work Order may be cancelled at any time before the expiry of its term due to non- satisfactory performance of the agency or if it is felt necessary by the authority for the interest of the Bank.
6. Time is the essence of the work order. It is to be ensured that the matters are to be published in the newspapers on the day as per the requirement of the Bank.

Contract Period: One year from the date of agreement.

Payment Terms: No advance payment will be made. Payment will be made after completion of the satisfactory service and submission of tax invoice / bill along with the original pages of the newspapers containing the notices for which the bill is raised by the agency.
